#### Tube Makers Club (TMC) Terms and Conditions for booking of Grounds / Main Hall

These terms and conditions are established to protect the interests of Tube Makers Club (TMC) and ensure that all bookings and events are conducted in an orderly, safe, and respectful manner. All clients, members, and their guests, friends, or relatives are expected to adhere strictly to these guidelines. By booking the TMC grounds and hall, you agree to the following terms and conditions:

#### 1. Booking Procedure:

- All bookings must be made through the Club's authorized event coordinator, Shri Krishna Enterprises (SKE). Direct bookings with the Club are not permitted.
- All bookings made for the services (Tent & Décor, Light, Sound & LED Wall, Catering, Flower Decorator, Manpower & Security, Event Company, etc.) will now be coordinated by Shri Krishna Enterprises (SKE) only.

#### 2. Responsibility of Club Members:

- Club members sponsoring or making bookings on behalf of friends or relatives are fully responsible for the conduct and behaviour of their guests during the event.
- The member is liable for any damages caused to Club property during the event. Compensation for damages will be assessed by the Club, and the member must comply with the Club's determination.

#### 3. Handover Time & Vacating Time:

- o Day before Event: Access to the premises is available starting from 2 PM.
- After Event: The premises must be vacated by 11 AM the following day. This includes clearing out all items and completing clean up by this time.

#### 4. Advance Payment:

- A 100% advance payment for the ground/hall rental is required within 7 days of booking, payable in favour of "Tube Makers Club".
- o Full payment for all services (Tent & Décor, Light, Sound & LED Wall, Catering, Flower Decorator, Manpower & Security, Event Company, etc.) must be made at least 10 days before the event to SKE. Any remaining balance, if applicable, should be cleared within 48 hours after the event, payable to SKE only. Failure to comply may result in cancellation of the booking without any refund of payments made.

### 5. Cancellation and Forfeiture:

- If full payment is not received within 7 days of booking, SKE is authorized to cancel the booking and forfeit any advance payments made.
- o If the booking is cancelled within 60 days of the event date, 50% of the total booking charges will be forfeited. If cancelled within 30 days of the event date, 80% of the total booking charges will be forfeited.

## 6. Liability for Natural Events:

- o The Club /SKE is not liable for any damages, losses, or injuries resulting from natural calamities or adverse weather conditions. The responsibility for safety and well-being lies with the customer/member, as well as the member's relative or friend for whom the ground or hall is booked by the club member.
- Club members/Customers/vendors/member's relatives or friends are fully responsible for all their belongings and materials used during the event/program. Neither SKE nor the Club will be held liable in case of any unforeseen incidents, such as theft or other unexpected events.

## 7. Prohibited Activities: The following activities are strictly prohibited within the Club premises:

- Barat processions, firecrackers, and band parties.
   Bringing animals & firearms inside the club.
   Religious ceremonies.
   DJ services and loud music.
   Bringing liquor from outside is prohibited. (Members/Customers must obtain a license/permit for serving foreign liquor, and a corkage fee will apply for serving it).
- 6) Light instrumental music/artist & band performances must end by 10:30 pm. Non-compliance will result in penalties and may lead to the termination of vendor contracts.

## 8. Electricity & Water Supply:

- The Club/SKE cannot guarantee uninterrupted electricity. It is the responsibility of the party/vendor to arrange for generators or alternate power sources at their own cost.
- o In the case of ground booking with kitchen facilities, an extra charge will apply. Water can be used up to the Club's available capacity. If additional water is needed, the member/guest must assess the requirements in advance and arrange for it at their own cost.
- Behaviour and Conduct: Any misbehaviour towards TMC staff, SKE representatives, or authorized vendors may result in the
   Immediate cancellation of the event and possibly the termination of the member's Club membership.
- 10. Indemnity: By signing the booking agreement, the member indemnifies the Club against any liabilities, including but not limited to, fire, food poisoning, or any untoward incidents during the event. Compensation related to these incidents will be the responsibility of the member, even if the ground or hall is booked for friends or relatives by the member.

#### 11. Authorized Vendors:

- Only SKE-authorized/Registered vendors for {Tent & Décor, Light, Sound & Led Wall, Catering, Flower Decorator, Manpower & Security, Event Company etc.} are permitted to work at events held at the Club's grounds or hall. No exceptions will be made, which should be very clear to all stakeholders.
- O However, as a special case, an exception can be made with prior written permission from SKE if an Event Management Company or vendors from outside Jamshedpur, or those not authorized/registered by SKE, are engaged. This will incur an additional charge of Rs.1, 00,000/- in addition to the standard ground and hall rates.
